

**RESOLUTION ESTABLISHING RATES, FEES, TOLLS AND CHARGES  
FOR THE LA PLATA ARCHULETA WATER DISTRICT**

**WHEREAS**, the La Plata Archuleta Water District ("District") was organized by Order of the La Plata County District Court, entered on August 19, 2008, and recorded in the records of La Plata County Clerk and Recorder on August 19, 2008 at Reception No. 982223; and

**WHEREAS**, the District was organized for the purpose of supplying water for domestic and other public and private purposes by any available means and to provide all necessary or proper reservoirs, treatment works and facilities, equipment, and appurtenances incident thereto, to the residents and property owners within the boundaries of the District; and

**WHEREAS**, the District has the authority to finance the services it provides through *ad valorem* property taxes, and through rates, fees, tolls and charges; and

**WHEREAS**, based upon the District's revenue requirements to provide such services, and based upon the recommendations which resulted from several public meetings, which included ratepayers, to discuss rate setting, the Board has determined that it is necessary to adopt a set of rates, fees, tolls and charges as so recommended.

**NOW THEREFORE, BE IT RESOLVED** by the Board of Directors of the La Plata Archuleta Water District as follows:


**Section 1.**     **Capital Investment Fees and Water Use Rates.** The rates, fees, tolls and charges to be assessed by the District shall be as set forth on Exhibit A attached hereto and incorporated herein by this reference.

**Section 2.**     **Public Health and Necessity.** The Board hereby finds and determines that the adoption of this Resolution is necessary for and promotes the public health, welfare and safety of the District and its inhabitants.


**Section 3.**     This Resolution shall become effective as of the date of its adoption by the Board.
